Cause: Loss of a driver's key while transporting the vehicle:

Instructions and procedure in the event of the loss of a driver's key while transporting the vehicle (prior to

vehicle delivery to the Porsche Center).

Action: If the loss of a driver's key is discovered during vehicle delivery (to the Porsche Center), always proceed in accordance with the procedure described below:

The complete set of locks must be replaced.

The missing driver's key must not (in compliance with anti-theft measures) be replaced by a single new

driver's key (remote control).

Information

As soon as the ordering process for a new set of locks / remote control is active, no further teaching processes needs to be carried out for the old set of locks / remote control in order to comply with safety regulations.

If this default value is not adhered to, the new set of locks / remote control is blocked and can no longer be programmed.


The new set of locks must be taught using the supplied remote control.

 \Rightarrow The teaching process gives the vehicle a **new "identity"**.

The set of locks consists of:

- Lock mechanism (with mechanical components),
 ⇒ Complete set of locks (sample illustration) -A- and
- two remote controls (including emergency key),
 ⇒ Complete set of locks (sample illustration) -B-.

If a replacement is required, a new set of locks is created especially for the vehicle, which must then be taught on the vehicle.
