Introduction

Some 2018 – 2019 model year C-HR vehicles may exhibit a condition where the door mirror foot light projects a distorted image of the C-HR logo onto the ground. Follow the Repair Procedure in this bulletin to address this condition.

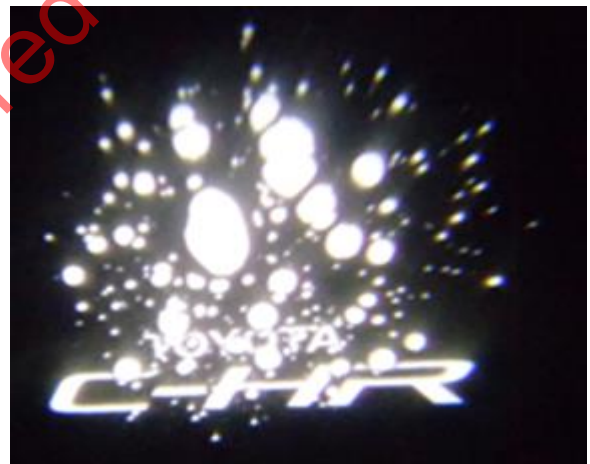
Repair Procedure

1. Confirm the "Toyota C-HR Distorted Image" condition exists.

Repair Procedure (continued)

2. Remove the outer mirror lamp assembly.

4. Confirm the C-HR logo projects correctly.
