ISSUE:

Model year 2025 Ibex 800 E motorcycles require DSCAN to reset the maintenance interval reminder, an alert that appears on the MMI dashboard when maintenance is due.

CFMOTO recently released a dashboard software update that allows the maintenance interval reminder to be reset from the MMI dashboard screen. All affected 2025 Ibex 800 E motorcycles need this update installed to add this functionality.

SOLUTION:

CFMOTO-USA is issuing this **MANDATORY Warranty Bulletin WAR-2025-06** for dealers to perform the dashboard software update on their sold and unsold inventory of affected Ibex 800 E motorcycles.

- **Sold Affected Units:** Dealers must notify owners as soon as possible and schedule a time to perform the dashboard software update per the CFMOTO warranty terms and conditions.
- **Unsold Affected Units:** Dealers must perform the dashboard software update before affected units are sold and/or delivered to customers. CFMOTO warranty registration for each affected vehicle will be blocked in the system until the bulletin is completed and the submitted claim is approved.

NOTE: For any affected vehicle sold and delivered but unregistered prior to the release date of this bulletin, dealers must complete the VIN Registration Change Request Form and select option 'VIN sold but cannot be registered.' This form can be found in the dealer portal under 'Inventory' > 'Forms and Updates' > 'VIN Registration Change Request Form (2025)'.

IMPORTANT DEALER NOTIFICATION

Per the terms of the CFMOTO Powersports Dealer Agreement, any dealer who sells a product without performing this warranty bulletin does so in violation of the dealer agreement terms. Any dealer who supplies warranty parts to a product owner for the purpose of self-repair is in violation of the dealer agreement terms.
