Certain **2021 – 2023 model year Santa Fe, 2021 – 2023 model year Santa Fe Hybrid, and 2022 – 2023 model year Santa Fe Plug-In Hybrid** vehicles may experience an inoperable horn that may be caused by foreign substances causing internal parts to oxidize. At Hyundai, we are committed to providing vehicles of outstanding quality and value. In an effort to meet this commitment, the warranty coverage for the **horn assemblies** under these conditions has been extended to 10 years / 120,000 miles from the date of original retail delivery or date of first use (whichever occurs first) and is valid for original and subsequent owners.

Our records indicate that your vehicle, with the VIN listed above, is covered by this warranty extension.

What should you do?

- Tear off the bottom portion of this letter along the perforation and place it in your Owner's Warranty and Maintenance Guide booklet for future reference.
- If your vehicle exhibits a problem related to the conditions during the extended warranty period, contact your Hyundai dealer to have your vehicle inspected. Otherwise, no further action is required at this time.

Warranty Extension

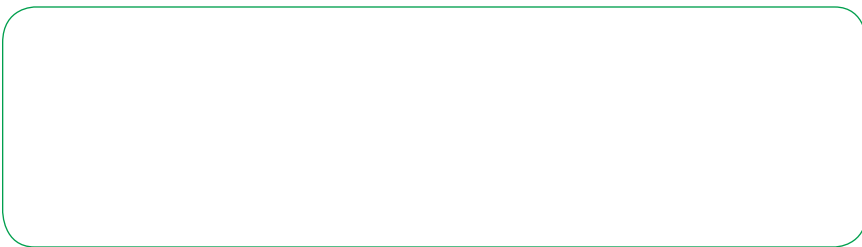
